### **Our Services**

There are two programs offered under the college & career pathways heading: WorkAbility I and We Can Work. Both programs offer and encourage paid work experience for high school students on an IEP. The We Can Work program also offers services to students on a 504 plan and can extend up to 1-year post graduation, as long as the student enrolls in a post-secondary education option. Programs:

- Provides pre-employment skills training, paid work experience, and follow-up services
- Offers special education students the opportunity to complete their secondary education while also obtaining marketable job skills.
- Benefits students, employers, and the community at large.
- Assess and interview students to assist with guidance towards post-secondary goals, including education and independence.

The WorkAbility 1 grant program is funded and administered by the California Department of Education. The We Can Work Program is funded and administered by the California Department of Rehabilitation.

### **Work Experience**

Butte County places more than 200 students out in the community for work experience each school year. Students ages 16 to 22 and still in high school can work up to 300 hours dependent on performance and employer availability. Students under 16 in high school can participate in an introduction to work experience for up to 10 hours. Students are paid the current CA minimum wage.

During any College & Career Pathways work experience, students will be covered under the Butte County Office of Education Workers' Compensation and General Liability Insurance policies.
