# More About the Butte County SELPA

Our SELPA and member local education agencies (LEAs) foster coordination between general and special education for prevention and early intervention of suspected disabilities. We ensure appropriate education services for individuals with disabilities by working cooperatively with other public and private agencies to support a full complement of special education services for students.

Our SELPA Administrative Unit is the Butte County Office of Education, which serves as the legal entity that receives funds and assists with mainly fiscal and human resources functions on behalf of all SELPA member districts. Costs for SELPA operations and the Administrative Unit are provided by funding from the state, which may be augmented by local, federal, and state funds.

Our SELPA has determined funds available for centralized services and the responsibilities of the SELPA office. The SELPA Governing Board, made up of 14 superintendents, is the policy-making body is designated in the Local Plan to approve the SELPA budget and Allocation Plan, and direct SELPA operations.

#### The SELPA Mandate

In 1977, all school districts and county school offices in California were required to form geographical regions of sufficient size and scope to provide for all special education service needs of children residing within the region's boundaries. Each region became known as a Special Education Local Plan Area – SELPA.

Today, there are over 130 SELPAs in the State. The SELPA governance structures, and size and scope, vary across the state. Each SELPA has a Local Plan describing how it provides special education services. Specific components to be included in the Local Plan are delineated in Education Code.

The SELPA Administrators of California is a statewide association consisting of nearly all SELPA directors, who meet regularly to obtain the latest information on data and compliance, best practices in student programs, legal updates, state updates, and important information in all related areas that support student success.
